Ethical issues surrounding Aboriginal and Torres Strait Islander collection of data and research (Australia)

"Within the research process, failing to understand difference in values and culture may be reckless act that jeopardises both the ethics and quality of research. However, to do better is not always straightforward. Working with a difference in a research context takes time, care, patience and the building of robust relationships" (NHMRC, 2003).

Ownership of data involves the same collaborative trust building process to ensure ethical

outcomes (NHMRC, 2003, AIATSIS, 2000). It is critical that researchers/ data collectors are prompted to ask whether the general research could contribute to the health of Aboriginal and Torres Strait Islanders through consultation with key stakeholders within the community (NHMRC, 2003; AIATSIS, 2000). Models that have proven to build this trust include:

- Greater reliance on participatory process
- > Innovative institutional arrangements with ongoing involvement of communities
- Legal agreements that codify substance
- ➤ Aboriginal community control over the research process
- Explicitly recognition and commitment to respect

Important to issues of ownership, researchers and data collectors need to conform to relevant legal requirements and Human Research Ethics committee (HREC) need to be satisfied that the conduct that they approve is lawful. Beyond law the guiding principles of the NHMRC (2003) and AIATSIS (2000) which focus on Aboriginal and Torres Strait Islander communities are based on reciprocity, respect, equality, meaningful engagement, survival and protection and responsibility.
