Wernham, A. (2007) Inupiat Health and Proposed Alaskan Oil Development: Results of the First Integrated Health Impact Assessment/ Environmental Impact Statement for Proposed Oil Development on Alaska's North Slope. Ecohealth. No. 4, pp. 500 – 513

I have put 4 quotes from the article to get you thinking about the topic:

1. "Subsistence is a way of life in rural Alaska that is vital to the preservation of communities, tribal cultures, and economies. Subsistence resources have great nutritional, economical, cultural, and spiritual importance in the lives of rural Alaskans... Subsistence, being integral to our worldview and among the strongest remaining ties to our ancient cultures, is as much spiritual and cultural, as it is physical"

- 2. "For years, Nuiqsut residents have expressed concern about the potential associations between oil development and health. In public hearings, residents have testified to concerns ranging from possible effects of contaminants (including cancer, asthma, and thyroid disease) to a rise in social problems such as alcoholism, domestic violence, and suicide... and, increasingly, to more generalized fears regarding the survival of Inupiat culture and tradition"
- 3. "The feelings of disempowerment that result when developments are approved repeatedly over such objections compound the problem"
- 4. "There is an imperative for collaboration between communities, environmental planners and regulators, and public health to address the growing burden of disease attributable to human-mediated environmental change."
